**UNOPPOSED MOTION FOR LEAVE
TO AMEND COMPLAINT**

The Consumer Financial Protection Bureau and the People of the State of New York respectfully move this Court for leave to amend their complaint to remove references to NFL player consumers and to remove allegations in Count VIII regarding violations of public policy. Defendants do not oppose the relief sought in this motion.

The Court's Scheduling Order, filed on May 9, 2022, expressly contemplated Plaintiffs seeking leave to amend their complaint. ECF No. 176. Plaintiffs requested an extension specifically to amend the complaint, which was granted on June 21, 2022. ECF No. 179. Leave to amend should be "freely given when justice so requires." Fed. R. Civ. P. 15(a).

Because Plaintiffs are seeking leave to amend before the deadline, the proposed amended complaint only removes language from the Complaint, Defendants do not oppose the amendment, and there is no basis for denying the unopposed motion, leave to amend is warranted. A copy of the proposed amended complaint is attached to this motion.
