1 Pursuant to Civil Local Rule 7-3(d)(2), Defendants Office of the Comptroller of the Currency  
2 and Michael Hsu, in his official capacity as Acting Comptroller of the Currency, respectfully submit this  
3 Statement of Recent Decision in support of their Motion for Summary Judgment (Dkt. No. 44), and

6 (W.D. Wis. Aug. 4, 2021).

7 *Lako*, which addresses whether a national bank's rights and duties under the National Bank Act  
8 are assigned to a non-bank third party where the national bank sells a debt to that third party, was  
9 decided after Defendants filed their Reply in Support of their Motion for Summary Judgment (Dkt. No.  
10 69) on March 19, 2021. A copy of the opinion is attached as Exhibit A.
